History of Master AIM (2010 – 2011)

Grenoble (France) 2010

- Motivation for a Master in Industrial Engineering and Management by lack of engineers, demographic change
- Draft of a possible international degree program for “Master of Advanced Industrial Management” as well as a curriculum

Survey of leading enterprises and organizations



Requirements of the participants are:


- Possibility to study at different universities across Europe with the same quality level
- Need for separate modules (e.g. Certified Process Manager) to qualify the employees in special core fields
- Flexible way of studying for the employees (e.g. extra-occupational study)



History of Master AIM (2012 – 2013)


Budapest (Hungary) 2012

- Idea of an EU funded Education Project with focus on methodical expertise and leadership skills needed by industry
- Fulfilment of Bologna Process-objectives (mobility, international competitiveness, European education)
- Integration of AIM into European Higher Education Area and recruitment of new AIM-fellows



Split (Croatia) 2013

- Definition of suitable lectures for each core field
- Examination of lecture content concordance
- Installation of a working group for the implementation of the Master AIM (J. Lundquist, A. Portioli, K. Santarek, H. Van Landeghem, U. Dombrowski)




Way from AIM over EU to EHEA – Fulfilment of Bologna Process requirements

Our goal is to complement the European Academy on Industrial Management with Fellows of each country of the complete European Higher Education Area.

Currently, there are AIM-fellows from 15 EU-states and 2 neighboring countries.

- Need for contact person for direct communication

Current status of accreditation process

Request of two accreditation agencies for degree programs



- Invitation to tender of ASIIN (Dr. Wasser) / ENAAEE (Prof. Dr. Remaud)
- Accreditation costs of ~20.000,- € for each university
- (Financing of accreditation by industrial partners possible)
- Support by vice president Research and Education of TU Braunschweig, Dean of faculty of mechanical engineering as well as department professors

Implementation difficulties

- Implementation of an independent “AIM European Master in Industrial Engineering and Management” requires new capacity calculation at each university
- Internal coordination with other course of studies with regard to teaching staff



Interim solution

- iTUBS – on-the-job-training as pilot project in Braunschweig
- No additional capacities needed
- Advantage: additional source of income

Introduction to Erasmus-plus-program

Budget

- Overall indicative financial envelope of 14.774 billion EUR (2014-2020)

Objectives

- Sustainable development of Partner Countries in the field of higher education
- Knowledge Alliances between higher education institutions and enterprises which aim to foster innovation, entrepreneurship, creativity, employability, knowledge exchange and/or multidisciplinary teaching and learning



Eligible countries

- “Member States of the European Union” (28 states)
- “Non EU Programme Countries” (7 states)
- “Partner Countries Neighboring the EU” (22 states)

Restrictions

- Organizations participating in Erasmus+ projects must be established in a Program Country
- Program is open to any organization active in the fields of education, training, youth or sport

- “stimulate entrepreneurship and entrepreneurial skills of higher education teaching staff and enterprise staff”
- “facilitate the exchange, flow and co-creation of knowledge”

Possible rules for AIM master graduation



1. Study at least at two foreign universities (definition of minimum number of credit points needed)
2. 30 credit points + master thesis at one foreign university



Master certificate awarding




1. Master thesis-supervising university
2. University that awarded most credit points
3. Awarding by all educating universities
4. Joint certificate by pilot universities
5. ...

Open item – extension of working group

Candidates for working group extension



- Support of communication between students and technological institutes in EU
- Member: 60.000 students in 29 European countries
- Representations in Braunschweig, Milan, Linköping, Warsaw
- Support as associated partner possible and advisable (but no funding)



- IIE contents and objectives similar to AIM (leadership, on-the-job-training, Six-Sigma-courses)
- Only two European chapters in Ireland, Portugal
- Support not expedient



- Inclusion of Russian university (e.g. St. Petersburg State University – Prof. Smirnov)
- Participation in Erasmus-plus-proposal is possible as EU-neighboring country
- Extension of working group advisable
